2. Relationship between the parties involved: John Brown Fox was my boyfriend.

3. The incident that is the reason for this Petition occurred on or about July 21, 2011

4. Describe the incident in as much detail as possible: John Brown Fox came over to my grandmother's house where I am living. He was outside honking his horn repeatedly at about 2:30 a.m. I then heard pounding on the front door and could hear him yelling for me to come out on the porch to talk with him. I was scared and went to the door to make sure it was locked and it was. John began to kick the door and started cussing at me. I then heard the living room window break - the one by the door. I saw his hand come through the broken window. He was trying to unlock the door. I was so scared. I told him to go away. He has hit me before and I was afraid for my life. I had a restraining order on him before in Sycamore City so I know how he acts. I picked up my car keys from the table and ran for the kitchen. John got into the house somehow and the next thing I know is that he grabbed my arm. I have bruises from where he grabbed me. All the time he kept yelling and cussing at me. I

could smell alcohol on his breath and he was acting drunk. He forced me against the kitchen wall and punched the wall missing my face by inches. I was screaming the whole time for him to leave me alone. He staggered backwards and looked away I think because dogs were barking. That is when I ran as fast as I could to my car. I got into my car and drove away. No one else was home at the time.

I want to request him to stay away from me, where I live, and where I work. I would like to have a restraining order issued as soon as possible by today.
