2022-2023 AILC and PLSI Bar Review Course Reimbursement Application

Eligibility - All American Indian and Alaska Native bar examinees who will take a state bar exam in 2023, have taken or will take a bar review course in 2022 or 2023, and have not been fully funded for the course are eligible for reimbursement of 85% of their bar review course cost up to a maximum of \$3,000. If a student received a partial scholarship, grant, or tuition remission for the cost of the course for which they are applying, they are eligible only for reimbursement of the uncovered portion of the cost. The reimbursement is not available to attorneys who have been admitted to a bar and are seeking admission in a different jurisdiction. **You must submit a law school transcript with your degree posted, previous bar exam scores, proof of tribal membership, itemized receipt, and other supporting documents for this application. Review the 2022-2023 AILC/PLSI Bar Review Course Reimbursement Guidelines before completing this application. PLSI attendance is not required.**
