* **SANTA CLARA PUEBLO COURT OF APPEALS (SCP):**
The Santa Clara Pueblo joined the Southwest Intertribal Court of Appeals (SWITCA) on June 25, 1993 by resolution 93-23 and appointed SWITCA as an advisory appellate court to the Santa Clara Pueblo Court of Appeals. Under the interim rules of appellate procedure adopted by the Pueblo on April 6, 1994 (resolution 94-14), SWITCA made recommendations to the Santa Clara Pueblo Court of Appeals on cases assigned. In turn, the Pueblo Court of Appeals could adopt, modify, or not accept the recommendations. Any SCP case denoted with an asterisk is a recommendation and not a final judgment. In September 1999, Santa Clara Pueblo granted full appellate authority to SWITCA to hear and decide appellate cases, and to publish opinions in this Reporter.
